Disruptive Change in the Taxi Business, 2016 In most cities the taxi industry is highly regulated and utilizes technology developed in the 1940s Ride sharing services such as Uber and Lyft which use modern internet based mobile technology to connect passengers and drivers have begun to compete with traditional taxis.
