Chapter Outline

1. Business organizations that are formed legally as partnerships, although they are not always so called by participants, are common throughout the country, especially in the legal, medical, and accounting professions.
 - a. Advantages of the partnership form include ease of creation and the absence of the double taxation often inherent in the profits earned by a corporation and distributed to its owners.
 - b. Partnerships, however, rarely grow as large as those often associated with large corporate organizations, possibly because of the constant liability facing each individual partner.
 - c. Although legal forms have been created that are used to combine the benefits of corporations and partnerships such as S corporations, limited liability partnerships, and limited liability companies.
2. Partnership accounting and the capital accounts
 - a. The different aspects of partnership accounting center on the capital accounts maintained for each individual partner.
 - b. The basis of accounting for these capital features is the basis of partnership agreement which involves the partners, the total investment, contributions, withdrawals, as well as partnership agreement, if so desired, etc.
 - c. The most common basis is the partners in the business should be treated as full capital units. In certain cases, however, when a partner is only temporary such as a particular investor or an associate that may:
 1. In the cost method, only identified assets are valued and recorded. The capital contributions are often agreed to include the percentage of the total contribution being made by each partner.
 2. In the goodwill method, the amount being contributed and the corresponding percentage of the total capital interest are used to calculate the value of the business and the percentage of goodwill or fair value is typically recorded as an original cost.
3. Partnership income allocation
 - a. At the end of each fiscal period, the revenues and expenses accounts must be closed out with the resulting income figure being assigned to the individual capital accounts.
 - b. The method of allocating income to the capital accounts should be consistent with the basis of accounting.
