When a company holds approximately 20% or more of another company's stock, it is considered to have significant control, which signifies the power one company can exert over another.

Generally accepted accounting principles (GAAP) recognize four different approaches to the financial reporting of investments in corporate equity securities:

2.Cost method for equity securities without readily determinable fair values.

3.Consolidation of financial statements.

Credit "Equity in Investee Income"

Journal to Record a dividend declaration by Little Company - answer✓✓Debit "Dividend Receivable"
