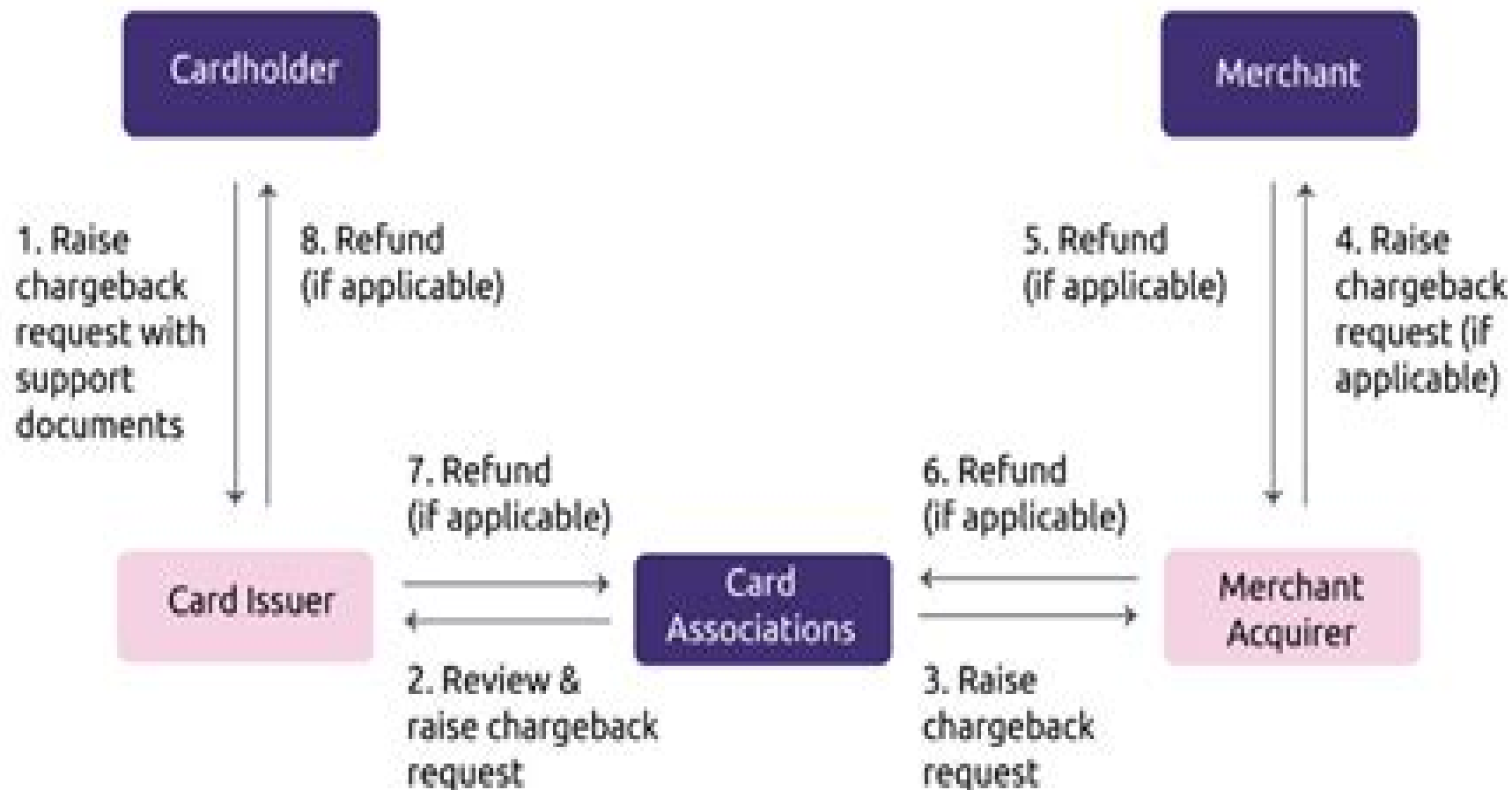


Chargeback Request Flow (Indicative)
