Cream Ltd produces a certain food item in a manufacturing process. On 1 November, there was no opening stock of work in progress. During November, 500 units of material were input to the process, with a cost of \$9,000. Direct labour costs in November were \$3,840. Production overhead is absorbed at the rate of 200% of direct labour costs. Closing stock on 30 November consisted of 100 units which were 100% complete as to materials and 80% complete as to labour and overhead. There was no loss in process.
